1. TOAST:

Area V Chairman Tr. Manish Kapoor, called the 1st AEX meeting of Area V for the year 2009-10 to order with a toast to President, Republic of India at 11.30 am.

2. READING THE NOTICE CONVENING THE MEETING:

Area V AST Tr. Mohit Arya read the notice convening the 1st AEX of Area V for the year 2009-10.

3. AIMS & OBJECTS:

Tr. Kartik Jaithalia (Chairman JJRT 191), read the Aims & objects of Round Table India.

4. APPOINTMENT OF SGT-AT-ARMS:

Tr. Harsh Gupta (DDRT 157) was appointed Sergeant-at-Arms for the meeting.

5. WELCOMING OF GUESTS:

Area V Chairman Tr. Manish Kapoor welcomed all the Board members, Table Chairmen of various tables & convenors.

6. APOLOGIES FOR ABSENCE RECEIVED

7. COMMUNICATIONS RECEIVED

AST Tr. Mohit Arya informed the floor of the communications received, which had already been forwarded to area email group.

10. REPORTS:

10. A. TABLE CHAIRMEN'S REPORT:

A format for the 1st Quarter Action Plan (QAP) had been floated to all the chairmen. The 1st QAP was discussed by all the chairmen present. The detailed 1st QAP of all tables is attached.

Other than the 1st QAP, the following points were proposed by the Chairmen present:

- 1. Tr. Sandeep Singhvi (Chairman, ULRT) The Chairman informed the floor, that the Charter Date for the new table has been fixed as 12th of September, at Kumbalgarh. Most of the board members present, confirmed their presence at the event.
- 2. Tr. Vikas Damani (Chairman, JHRT 185) Tr. Vikas informed the board, that the three tables of Jaipur i.e. JPRT 171, JHRT 185 & JJRT 191 have proposed to jointly host a social on the eve of the next AEX in JAipur, i.e. on the 31st of October.
- 3. Tr. Kunal Gupta (Chairman, DMRT 149) Tr. Kunal proposed an inter region cricket tournament involving teams from Delhi, Punjab, Rajasthan and Dehradun. All the Chairmen present confirmed their participation in the event. It was proposed that the same be clubbed with some other event such as the AEX or mid-term meet. Tr. Kunal assured that he will explore all the possibilities, and float a concrete proposal to the floor, shortly.

- 4. Tr. Amit Khanna (Chairman, ART 203) Tr. Amit, briefed the floor on a proposed project with regard to cataract operations. He requested for information with regard to the modalities and risks associated with such projects, as the operations sometimes can go wrong, leaving the organisation open to legal hassles. Tr. Abhishek, DMRT 43 briefed the floor, on the various modalities, as this is a project that they have been undertaking on a large scale, over the last 2 years. After a lot of discussion, the following was decided:
- i. It was decided that legal opinion would be taken for a disclaimer, before conducting such kind of projects.
- ii. It was decided that rather than do small individual projects for cataract operations, we would have 1 table spearheading the effort in each area (43 for Delhi, and 203 for Punjab). For, Rajasthan, and Dehradun it was not decided whether they would like to do it or to tie up with 43/203. The idea is that if tables combine jointly to take up the project (spearheaded by a single table), the size of the project is much greater, which results in greater visibility to the movement.
- 5. Tr. Kartik Jaithalia (Chairman, JJRT 191) Tr. Kartik informed the floor, that due to health reasons, their current table secretary was unable to carry out his responsibilities. Tr. Sandeep Hora had been appointed the new Table Secretary. The area board agreed to waive the mandatory requirement of having undergone the TExT program, as this was a special case. However, AC Munshi assured the floor that a make up Text Program would be held specially for Tr. Sandeep at a later date.

10. B. AREA CHAIRMAN'S REPORT:

Tr. Manish Kapoor (DWRT 50)

The Area Chairman (AC) thanked all the Table Chairmen for their 1st QAPs.

- ♣ Being the 1st AEX of the year, the AC wanted to lay down some ground rules :
- The AC emphasized the need for the AEX meetings to start on time, and requested all the Chairmen and Convenors to maintain the time for the scheduled start of the meeting. He further announced that in future, all late arrivals at the AEX meetings would be fined heavily
- ii. The AC informed the board members that the dress code for future AEX meetings would be formal attire (atleast collared shirts and trousers ties recommended but not mandatory).
- The AC informed the board members, that the quarter would be defined as the period from AEX to AEX. He informed the Table Chairmen/Secretaries, that their QAPs/Quarterly Reports, would have to be sent to the AST, at least 15 days prior to the next AEX.
- Tr. Punit Jindal suggested, a standardized format/Template, for all reports prepared by Table Chairmen, or convenors. AST Tr. Mohit Arya informed, that a standardized format had already been floated to all the Chairmen for the 1st QAPs. He further informed, that a standardized format would be floated in advance to the Table Secratiries, to help them prepare their quarterly reports.
- The Chairman invited Tr. Karun Kandoi (JJRT 191), to join the Area Board in the capacity of Projects Convenor (Rajasthan), which he accepted.
- The AC informed the board, that through his personal efforts, he had already been successful in raising Rs. 1,30,000/- from sponsors, by assuring them of adequate coverage and

representation at the Area events. A further sponsorship amount of Rs. 1,20,000/- was in the pipeline.

- The AC informed the board, that these funds would be used to help out Tables, which have undertaken projects, but are facing a shortfall in their budgets. Tables would have to apply for the funds through a detailed application, listing the various facets of the project, the funds required, the individual efforts made to raise the funds, and the reasons for shortfall. The final decision, with regard to the same, would be made by the Area Head Board.
- The Area Board decided to make a sponsorship of Rs. 10,000/- from the approved budget, to the Ladies Circle (Area V), to help them with their arrangements for hosting the LC International delegates.
- ♣ The AC informed the floor, that a proposal had been received to merge the mid-term meet with the NAGM. But after consulting the host table, it was decided that the mid-term meet would be held as a separate event. It was decided that the mid term dates would be fixed, so as to co-incide with the PMT (Peacock Mass Tour), which is scheduled to be held in February 2010.
- The AC informed the board, of a new initiative, to start quarterly awards for the best Table Chairman, and the best Area Convenor. The awards would be decided based on implementation of their quarterly plans.
- The AC informed the board, that only 1 nomination had been received for the post of NHT from DMRT 149 proposing the name of Sq. Leg Ravi Baid for this honor. The floor unanimously approved the candidature of Sq. Leg Ravi Baid as the NHT nominee from Area V.

10. C. AREA SECRETARY / TREASURER'S REPORT: Tr. Mohit Arya (DMRT 149)

The AST thanked all the Table Chairmen for forwarding their 1st QAPs on time. The QAP for the following tables have been received – (5, 43, 50, 130, 145, 149, 157, 171, 184, 185, 188, 191, 202, 203, ULRT). The Chairmen of the remaining 4 tables assured that the same would be forwarded shortly.

Considering that the Area AGM has been held a month earlier this year, the AST proposed that the last date for submission of D Form dues be brought forward to the 31st of August this year. The Area Board unanimously agreed to the same.
